### Survivor Participant Agreement & Release Waiver

This agreement is between the participant (noted above) and the ZOMBIE BLOOD RUN Event (herein referred to as the EVENT) in addition to the event producer, Zombie Blood Run LLC & Hollywood Sports Park LLC (herein referred to as PROMOTER).

1. I understand and agree that I am at least 18 years of age prior or on the day of the EVENT. I understand that I must present a valid government issued photo ID at the time I check in at registration for the EVENT. If I am under the age of 18 on the day of the EVENT, I understand that I must have the signature of a parent or legal guardian in order to be permitted to participate in the EVENT. There will be no exceptions to this.
2. I understand the nature of the EVENT and I am aware that my participation in the EVENT will be of a physical nature wherein I will be running, jumping, crawling, climbing and engaging in other physical activities as part of the EVENT. I agree that I am in good physical and mental health with no pre-existing medical conditions that would prevent me from participating in the EVENT and all of the aspects therein.
3. I understand that as a Runner participant, I will be chased by zombie performers throughout the course of the EVENT. I understand that these zombie performers may touch me in an attempt to take my health flags from me and that this is part of the entertainment and strategy of the EVENT (this is a similar game strategy as "flag football"). I understand that the zombie performers will abide by a strict set of guidelines and rules that ensure my safety during participation in the EVENT.
4. I understand and agree that I will not touch, hit, strike, or engage in any physical conduct with other Runner participants or zombie performers during my participation in the EVENT. I understand that any violation of the rules for the EVENT will be considered a breach of this agreement and can result in my disqualification and potential ejection from the EVENT, with NO REFUND.
5. I understand that the EVENT will take place, rain or shine, on Saturday, January 28, 2017. I also understand that there are NO REFUNDS after I have registered and purchased my ticket. I further understand and agree that there will be no refund under any circumstances, including but not limited to injury, a scheduling conflict, Acts of God (including fire, flood, earthquake, storm, hurricane or other natural disaster) and/or event cancellation.
6. I understand that the EVENT is an intensive and interactive obstacle course that will challenge me physically. I also understand that there will be structures that will contain a variety of lighting effects, artificial smoke and other special effects that I will experience as part of my participation in the EVENT. I understand that if I do not want to complete any of the obstacles or mazes that are part of the EVENT, that I may be provided a detour route by EVENT staff so that I may continue to participate in the EVENT. I understand that if I choose not to participate in any of the obstacles or mazes that are part of the EVENT, I will not receive a refund of any kind.
7. I understand and agree to follow all of the posted and noted rules for participation in the EVENT.
8. I agree to follow any instructions given to me by EVENT staff and personnel.
9. I understand that the PROMOTER or EVENT PROVIDER (Hollywood Sports Park) will not cover any medical expenses resulting in injury incurred as part of my participation in the EVENT. I understand that there is no medical insurance coverage as part of my ticket purchase for the EVENT.

10. I agree that I will conduct myself in a careful and respectful manner at all times during the EVENT and will not injure or damage any other person or property.
11. I understand and agree that if I arrive at the EVENT under the influence of alcohol or any kind of drugs or narcotics, that I will not be admitted into the EVENT and will receive no refund as a result.
12. I understand that if I am injured or have any other type of loss or damage (including theft of personal property), I will not make any claim against the PROMOTER. I will also indemnify (reimburse) PROMOTER if any other person makes a claim against it for anything I did or am responsible for.
13. I hereby agree and authorize PROMOTER or EVENT PROVIDER (Hollywood Sports Park) to record my voice, photograph and record (on film, tape, photographs or otherwise), my participation in the EVENT. I understand and agree that PROMOTER or EVENT PROVIDER (Hollywood Sports Park) has without limitation, the right to use my likeness, voice and name in all forms of media, worldwide, in perpetuity with regards to the marketing, promotion, merchandise and advertising of the EVENT. I understand that there will be no compensation for said use. I further acknowledge that PROMOTER or EVENT PROVIDER (Hollywood Sports Park) owns all rights, in perpetuity, to the results and proceeds of my services rendered in connection herewith.
14. I understand and agree that my being permitted to participate in the EVENT is adequate consideration for the releases, waivers, and indemnities given herein.
15. I, the parent or legal guardian of the above named participant (MINOR), give my approval for MINOR's participation in the EVENT. I assume all risks and hazards incidental to the MINOR's participation in the EVENT and I release, waive discharge, absolve, indemnify, agree to hold harmless and covenant not to sue the Releases for any claim arising out of an injury to the MINOR and from any and all claims, causes of action, obligations, lawsuits, charges, complaints, controversies, damages, costs or expenses of any kind, nature, or description, whether direct or indirect, in law or in equity, in contract or in tort, or otherwise, whether known or unknown, arising out of or connected with MINOR's attendance at and participation in the EVENT, whether or not caused by the Releasees negligence or gross negligence. I consent to the foregoing, grant permission for MINOR to participate in the EVENT and acknowledge that I have carefully analyzed, accepted and agreed to the terms of this Agreement and Release Waiver, and that I know and understand its contents and sign below on my own free act and deed. Minor participating in the EVENT must be accompanied by a legal guardian.
16. I hereby on behalf of myself, my heirs, executors and administrators waive and release any and all rights and claims against the following entities and persons, and agree to indemnify and hold harmless the following entities and persons: Zombie Blood Run LLC & Hollywood Sports Park, and any other entity involved with the EVENT, their officers, directors, agents, employees and event volunteers, with respect to any and all liability of any nature in any way arising out of the EVENT and my participation therein, including not by means of limitation, the condition of the premises in or around the EVENT course. The foregoing release of liability includes all liability with respect to my travel to or from the EVENT. I agree that there are no cancellations or refunds or transfers of my registration fee.
